Mr. Sampson beneficially owns 1,153,707.178 shares of the outstanding common stock of the Issuer, which includes: (i) 1,071,079 shares of common stock owned by Mr. Sampson individually; (ii) options held by Mr. Sampson and exercisable within 60 days of December 31, 2010 to purchase 9,000 shares of common stock; (iii) 42,581.178 shares of the Issuer held by Mr. Sampson through the Communications Systems, Inc. Employee Stock Ownership Plan ("CSI ESOP"); (iv) 16,323 shares owned by Mr. Sampson's spouse; (v) 7,000 shares held in a trust account for the benefit of Mr. Sampson's children and grand children; and (vi) 7,724 shares held by the Sampson Family Foundation, a charitable foundation of which Mr. Sampson is the sole trustee. Mr. Sampson is also a trustee of the CSI ESOP. As of December 31, 2010, the CSI ESOP held 539,944 shares of the Issuer based on information provided by CSI. Mr. Sampson disclaims any beneficial ownership of the shares of the Issuer owned by his spouse; the trust account for his children and the Sampson Family Foundation and disclaims beneficial ownership of any shares of the Issuer held by the CSI ESOP in excess of the shares allocated to his individual CSI ESOP account, which totaled 42,581.178 shares.
